Please join us for the **Lexington Spring Dressage** show on **Saturday and Sunday, May 22-23, 2021** at the Virginia Horse Center in Lexington, VA. The competition includes Dressage and Dressage Sport Horse Breeding (DSHB) classes and will use the Anderson Coliseum as well as nearby covered and outside rings.

Indoor vendors as well as mobile vendors, including vendor supplied trailers or tents, can be accommodated inside or near the coliseum and barns that will be used for this event.

Several of our sponsors have exclusive vendor rights at this and other Rosinburg Events competitions. We cannot accept any tack/riding apparel shops or insurance companies as vendors. In addition, the facility may limit and must pre-approve all food or beverage vendors. However, businesses that sell equestrian gifts and other specialties or services are welcome to attend.

Vendors must furnish Rosinburg Events, LLC with a Certificate of Insurance as evidence that Worker's Compensation Insurance (if applicable) and Public Liability Insurance is in force during the show. In addition, a photocopy of your Virginia State Certificate of Registration, which serves as evidence that you have met the sales and use tax registration requirements for that jurisdiction and that you are authorized to collect and remit tax as required by law.

**Please note that vendors are REQUIRED to ensure face coverings are worn and social distancing is maintained by all staff and visitors to your business at all times. By submitting the contract and payment, you are agreeing to these conditions from the time of arrival to departure from the grounds.**

When your contract is returned, **with full payment**, you will receive confirmation for your vendor space. Trade Fair spaces will NOT be reserved until the contract and fees are received by the show.
