Please join us for the Raleigh Summer Dressage I & II shows on Saturday and Sunday, July 26-27, 2014 at the *outdoor rings* on the west side of the Hunt Horse Complex on the North Carolina State Fairgrounds in Raleigh.

As in the past, this year's events include Dressage and Dressage Sport Horse Breeding (DSHB) classes on both days.

Note that this is an OUTDOOR competition. The main coliseum at the Hunt Horse Complex will be used by a Hunter/Jumper competition. Mobile vendors, including vendor supplied trailers or tents, can be accommodated at this event. A limited number of vendors can set up in Barn F where our Awards trailer is located. Barn F has a concrete floor and easy access to electricity.

Several of our sponsors have exclusive vendor rights at this and other Rosinburg Events competitions. We cannot accept any tack/riding apparel shops or insurance companies as vendors. In addition, the facility may limit and must pre-approve all food or beverage vendors. However, businesses that sell equestrian gifts and other specialties or services are welcome to attend.

Vendors must furnish Rosinburg Events, LLC with a Certificate of Insurance as evidence that Worker's Compensation Insurance (if applicable) and Public Liability Insurance is in force during the show. In addition, a photocopy of your North Carolina State Certificate of Registration, which serves as evidence that you have met the sales and use tax registration requirements for that jurisdiction and that you are authorized to collect and remit tax as required by law.

When your contract is returned, **with full payment**, you will receive confirmation for your vendor space. Trade Fair spaces will NOT be reserved until the contract and fees are received by the show.
